

Premade Covers & Social Media Graphics T&Cs



1. General T&Cs

- All proof images will be sent with my watermark. Unwatermarked images will only be sent once the final payment has been received.
- Due to the digital nature of the products, no cancellations will be possible after the final files have been sent, and no refunds will be made.
- Payment is to be made via PayPal only. You do not need a PayPal account as you can make a payment with a debit or credit card through the service. Payment should be made within 48 hours.
- Amatti Book Covers reserves the right to cancel orders if the client is deemed to be offensive, impossible to please, or in any other way shows themselves to be unable to be worked with. Any refund in this situation will be decided on a case by case basis and the amount refunded will be determined by the cause of the cancellation and the stage at which the order is cancelled.
- Amatti Book Covers also reserves the right to refuse to accept any custom work she deems unsuitable. This includes, but is not limited to, anything verging on pornography, explicit violence, and gore.

2. Premade Book Covers

- To maintain exclusivity of the covers, book covers will only be sold once, on a first-come-first-served basis. The exception to this is in the case of an order being cancelled, whereupon the design will be made available for purchase again.
- Covers can be reserved for up to 6 months by paying 25% of the price. This will count towards your deposit when you place your order and can be cancelled at any point in this period for a proportional refund. A reminder will be sent out one month before the reservation period expires. Reservations can be extended for an additional \$15/£10/€12 per month, however this will not count towards the overall price of the cover and will not be refundable.
- 50% of the order total will be taken as a deposit when the order is placed, with the remaining balance to be paid once the final design has been confirmed and the files are ready to send.
- Orders can be cancelled with a full refund up until the final sign-off by the customer.
- Personalisation of book title, author name, and taglines are included in the price. Other alterations available on request and may be subject to additional fees depending on the complexity of the changes.

3. Additional Extras

- Additional extras can only be ordered at the price shown as an add-on to a book cover order. To order items with a book cover not created by me, please email saffron.amatti@gmail.com for a quote.
- Additional extras can be added to your book cover order at the time of ordering the cover, before the final payment is made, or after the book cover order has been completed. If ordered after the cover but before final payment, the whole cost of the additional extras will be added on to the final payment. If ordered after the final payment, 50% of the value of the goods will be required up front, with the remaining balance to pay on completion.
- Orders can be cancelled with a full refund up until the final sign-off by the customer.

4. Social Media Graphics etc.

- A non-refundable deposit of 50% of the order total will be taken to confirm the order, with the remaining balance to be paid once the final design has been confirmed and the files are ready to send.
- Prior to the final sign-off by the customer, unlimited revisions are included in the price.
- It is the responsibility of the customer to supply any quotes or text they wish to appear on social media graphics, and to check everything is correct prior to the final sign-off on the cover. Alterations made after the final sign-off will be subject to additional charges.
